From the President - Peter Hourn

Wow, what a finish to the year! COVID-19 has certainly left its mark on everything and everyone. Not the least being the end of the patrolling season, which saw the last weeks of patrols being completed with the flags down and only surveillance patrols. This was certainly different especially with the near-perfect conditions thrown up by the weather. What better place to have to be in isolation than our stretch of beach?

A huge thanks to all our patrolling members for the season just completed. Once again there were no fatalities on our stretch of beach, which I'm sure could have been different if it wasn't for all your efforts. As you can see from our patrolling statistics it was a busy season:

- 7,024 patrol hours completed
- 14 lives saved
- 472 preventative actions carried out
- 101 first aid cases treated
- Approximately 20,308 people visiting our beach over the season

A big thank you goes to our Club Captain, Rob 'Jenko' Jenkins for the countless hours that he has put in this year. It has ensured that our season has run smoothly with only a few minor hiccups.

To Riley Palmer and his team of Trainers and Assessors, thank you for training our new members and (probably an even harder task) keeping the rest of us proficient and up to date with what is required.

To the Committee Members and Club Officers, thank you for your time and effort in keeping the Club running as smoothly as possible. These people put in a huge amount of time that goes on behind the scenes and largely unnoticed. Sorry, I can't mention all of you, but your efforts are greatly appreciated!

Thanks to the Supporters Club and Committee, led by Craig Hunter-Smith. We should never under-rate the financial contribution from the Supporters Club. Without their support, the Marcoola Surf Life Saving Club would struggle to exist. It is a testament to the Supporters Club that they have still managed to meet budgeted money commitments to Surf (through rent and donations) despite COVID-19 impacting trading over the last couple of months of the financial year. There will be many challenges for them next year but I'm sure that under Craig's leadership we will come out the other side stronger than ever.

Junior Activities had yet another bumper year under the leadership of Amanda Janssen, who with the help of her committee reached almost 200 nippers this year. I'm sure Amanda will thank all involved in her report, but from the Surf Committee, congratulations on a stellar year. It was just a pity that the season ended prematurely due to COVID-19.

On the competition front, it was another quiet year for the club, on the beach and in the water, but our boaties are gaining traction and performed admirably in a shortened season. I'd like to acknowledge the efforts of our Champion Patrol Team: Saxon Jeffcoat, Em-jay Jeffcoat, Shasta Wulf & Aaron Barnard and Champion Lifesaver Em-jay Jeffcoat, incredible results at both Branch & State Competition for their first crack at it. It was a shame for all that States and National Competitions were cancelled but there is always next year.

The 50-year celebrations ended after the Past & Present Members Weekend, which was well attended and after some editing hold-ups, the history book was finally published. Please see the office if you would like a copy.

At the time of writing, we are slowly coming out of COVID-19 restrictions, reopening the Supporters Club, and holding discussions about how Surf Lifesaving can get back to training and what the new season will look like. It will be a challenging time, but the Club is in a very sound position, due to the efforts of many over past years.

The 2019-2020 financial year was certainly a challenging one in many ways - not just financially. The 2019 off-season started with our Emergency Response Group conducting the second body search in a matter of weeks, followed by the worst bushfires on record, some staff and committee changes and wrapped up with the COVID-19 Pandemic!! WOW – what a year!

COVID-19 resulted in the Supporters Club being closed for business for all of April and May, as well as parts of March and June. This massive loss of income resulted in them being excused from paying rent for March and April 2020 but as they were ahead in Donations (compared to the previous year) the overall income from Supporters to Surf has met budget. A great achievement by the staff and committee! Thank you!

Overall raffle income was down approximately \$20,000 this year, but we did not have a Surf Girl entrant this year. Last year our Surf Girl entrant Kirralee raised \$38,000.

Note 1 Summary of Significant Accounting Policies

Financial Reporting Framework

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 1981 (Queensland). The committee has determined that the association is not a reporting entity.

Statement of Compilance

The financial report has been prepared in accordance with the Associations Incorporation Act 1981 (Queensland), the basis of accounting specified by all Association of Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054; Australian Additional Disclosures.

Basis of Preparation

The financial statements have been prepared on an accruat basis and are based on historical costs. They do not take into account chancing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

(a) Income Tax

The Club has received an exemption from Income tax from the Australian Taxation Office under Section 50-40 of the Income Tax Assessment Act 1997.

(b) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful tives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The deprectation rates used for each class of deprectable assets are:

(c) Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have been impaired, if such an indication exists, an impairment text is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value to use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

(d) Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

(e) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(f) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposite held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(a) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(h) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

fil Revenu

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising resemble.

Revenue recognition

The Association has applied AASB 15: Revenue from Contracts with Customers (AASB 15) and AASB 1058: Income of Not-for-Profit Entities (AASB 1058) using the cumulative effective method of initially applying AASB 15 and AASB 1058 as an adjustment to the opening balance of equity at 1 January 2019. Therefore, the comparative information has not been restated and continues to be presented under AASB 118: Revenue and AASB 1004: Contributions. The details of accounting policies under AASB 118 and AASB 1004 are disclosed separately since they are different from those under AASB 15 and AASB 1058, and the impact of changes is disclosed in Note 1.

in the current year

Operating grants and donations

When the Association receives operating grant revenue or donations, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the Association:

- Identifies each performance obligation relating to the grant;
- recognises a contract liability for its obligations under the agreement; and
- recognises revenue as it satisfies its performance obligations.

When both these conditions are satisfied, the Association:

- recognises the asset received in accordance with the recognition requirements of other applicable Accounting Standards (for example, AASB 9, AASB 16, AASB 116 and AASB 138);
- recognises related amounts (being contributions by owners, lease liability, financial instituments, provisions, revenue or contract liability arising from a contract with a qualoment; and
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract flability is recognised as a related amount above, the Association recognises income in profit or loss when or as it satisfies its obligations under the contract.

Capital grant

When the Association receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The Association recognises income in profit or loss when or as the Association satisfies its obligations under the terms of the grant.

Interest income

Interest income is recognised using the effective interest method.

Income from sale of good

Revenue is recognised when control of the products has transferred to the customer. For such transactions, this is when the products are delivered to the customers. Revenue from these sales is based on the price stipulated in the contract, net of the estimated volume discounts.

Where there are expected volume discounts payable to the customers for sales made until the end of the reporting period, a contract liability is recognised.

A receivable will be recognised when the goods are delivered. The Association's right to consideration is deemed unconditional at this time as only the passage of time is required before payment of that consideration is due.

Historical experience of product returns is used to estimate the number of returns on a portfolio level, using the expected value method, it is considered highly probable that significant reversal in the cumulative revenue will not occur given the considered in the rate of return presented in the historical information.

All revenue is stated net of the amount of goods and services tax.

In the comparative period

Non-reciprocal grant revenue was recognised in profit or loss when the Association obtained control of the grant and it was probable that the economic benefits gained from the grant would flow to the Entity end the amount of the grant could be measured reflably.

If conditions were attached to the grant which must be eatisfied before the Association was eligible to receive the contribution, the recognition of the grant as revenue was deferred until those conditions were satisfied.

When grant revenue was received whereby the Association incurred an obligation to deliver economic value directly back to the contributor, this was considered a reciprocal transaction and the grant revenue was recognised in the statement of financial position as a liability until the service had been delivered to the contributor, otherwise, the grant was recognised as income on receipt.

The Association received non-reciprocal contributions of assets from the government and other parties for no or nominal value.

These assets were recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of profit or loss and other comprehensive income.

Donations and bequests were recognised as revenue when received.

Interest revenue was recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Rental income from operating leases was recognised on a straight-line besis over the term of the relevant leases.

Revenue from the rendering of a service was recognised upon the delivery of the service to the customer.

From the Emergency Response Group - Dave McLean, ESM & Brian Goulding

Whilst COVID-19 certainly did affect our calls for service we still managed to respond to several calls. In June we sadly lost one of our own when former Lifesaver Natalie Ward was sadly taken from us. May she rest in Peace

In July: In what was to be an almost déjà vu moment only some seven weeks after the tragic drowning of a jet skier at the end of last season, Marcoola members were called in again off season to assist with a missing free diver who had not resurfaced at Old Woman Island. Marcoola members went above and beyond again and along with multiple Lifeguard units, Helicopters, Coastguard, Police and Mudjimba members, a full-scale search concluded when the twenty-five-year-old male diver was located deceased on the ocean floor.

Former Surf Club member John Stewart, an experienced free diver assisted crews and located the patient whilst Water Police were arranging Police Divers from Brisbane. Marcoola Crews assisted the LG Supervisor and Water Police in the transportation of the deceased. It was a tragic end to a fishing adventure.

We sincerely thank the following members for giving up their off season in another extensive search and rescue operation along with many others who offered assistance.

Even though a surfboard was located and given to Police it turned out to be a false alarm and no one had been in trouble. The surfboard was returned to its owner who happened to leave it behind at an inopportune time which created confusion for Crews and Police that attended.

In September: We provided support to QLD Police during the Peregian Bush Fire Emergency by lending them gear and equipment for their forward command post gaining National Television coverage at the same time.

In October: Duty Officer Dave McLean received a call at 19:07 to assist Sunshine Beach SLSC members and QPS in a search for two males who had gone missing at Sunshine. The two males had been with a third male who had fallen asleep on the beach whilst his two friends were in the water and when he woke up his two friends were missing. LS 46 was also tasked along with multiple Police units and whilst they were en route it was discovered that the two males had wandered up the beach and not into the water. All assets were stood down.

Our Duty Officers were also tasked at 17:25 to Noosa for two missing surfers who were located whilst en route to the scene.

In November: At 17:25 members D. McLean, B. Goulding, P. Hourn, L. Hourn, G. Jeffcoat and A. Schmidt were called to reports of a male SUP rider in trouble 100m off Boardwalk LG tower. An extensive search was conducted and LS46 placed on standby and POL AIR became airborne from Caboolture. Crews used 4WD's and SSV along with Police vehicles to search from Mudjimba to Yaroomba. Police were happy with the search conducted and stood all assets down at 18:35 at last light.

Marcoola Members Amanda Janssen and her band of trainers doing Nipper board training were alerted at 17:46 to a male with a dislocated shoulder at Beach Access 98 where Lifeguards had finished for the day. The patient's friends had run to the Surf Club to get assistance. Amanda and her team dealt with the injury until QAS arrived and the patient was transported to hospital.

In February: Duty Officers were tasked with Operational Support to two Jet Skiers who had come adrift in Pumicestone Passage whilst the SLSQ Tasking Officer investigated on scene. The two males made it back to the boat ramp and confirmed with Police and SLSQ that they were the ones in trouble.

In March: Dave McLean and Brian Goulding were tasked to an overturned vessel at Maroochy River Mouth at 06:15. Upon arrival along with QAS the vessel was located some 15m offshore. Assistance was given to bring the 3m tinny to shore. The three occupants were assessed by QAS and then returned by Marcoola 4WD to their vehicle to retrieve their trailer and boat. Indeed, a lucky escape.

In April: We received a call from SLSQ Tasking Officer re four persons clinging to a kayak at Peregian. Due to the call coming in at 18:20 and fading light a full night time qualified Search and Rescue team was tasked, which included Members D. McLean, B. Goulding, B. Mills, J. Goulding, G. Jeffcoat and A. Schmidt along with two Noosa night qual Jet Ski Crews and multiple Police units as well as the POL AIR Helicopter and an on-scene off duty Lifeguard. POL AIR was tasked from Brisbane and Marcoola crews liaised with QPS on scene whilst Noosa crews prepared the skis for a night-time search.

Crews had no light, but favourable conditions. However, they also had to deal with friends of the missing persons becoming hysterical. Fortunately, there were only two persons who had been fishing on a kayak and were located several hundred metres to the north. They had been fishing and were not in any danger. The search was called off at 18:17 once Police confirmed the males were the ones in question.

The above call outs are always a timely reminder of the inherent dangers of the ocean and our need for Vigilance and Service. We commend our members who go above and beyond their normal call of duty to provide this value, added assistance and lifesaving service for Surf Life Saving Qld and the general public.



From the Chief Training Officer - Piley Palmer

As the season winds down, it feels quite different reflecting on the year that was. Without dwelling on the Coronavirus threat, this season was very successful for training. Although, it did not come without its challenges. The only way I get through it all is due to the help of our Trainer, Assessor and Facilitator team. I am very grateful for the calibre and knowledge that our team has. It is always a pleasure working with such an experienced and seasoned group of people.

As always, starting the season with the September Bronze/SRC squad is always a brilliant and rapid introduction to what will come over the next eight months. While a smaller group than usual, we were still very impressed with what the participants achieved over the week. Especially for the SRC's, they progressed in leaps and bounds and were well equipped by the end of the week. As always, a massive thank you to all my trainers, water safety and helpers, your work does not go unnoticed. Special mention to Jill Hamilton, it was never my intention to hand over so much of this course but as always, you took it like a champ and we now have eleven more Bronze Medallion holders and six more SRC's patrolling our beaches.

I was very happy with the response to Skills Maintenance this season. There were some key changes and additions, especially around application of tourniquets and changes to severe bleeding treatment. Exclusion zones were introduced around the shark nets. As always Marcoola members were eager to learn and refresh their skills. We only had eight members non-proficient by December 31, 2019. Just remember, the earlier you complete it, the easier the conditions will be for you.

The traditional six-week course kicked off in October, thanks to John Ward and Jill Hamilton for helping run this course. Another fourteen Bronze Medallion and three SRC holders added to the patrol roster. It has been great to see these new members take lifesaving in their stride and get involved with the many facets that the club has to offer. Marcoola is having high success with the Nipper parent pathway, what better way to help out on a Sunday than to be in the water with your kids. I highly encourage all parents to consider this option, it makes the morning go much quicker, I promise!

I would also like to acknowledge the contribution from Marcoola SLSC to ensure that all our TAF team are upskilled. There is a lot of work that goes into being a Trainer, Assessor, Facilitator and with the introduction of the new Certificate IV in Training and Assessment, plenty of upgrades took place for our team this year. It was a massive commitment for our team to make sure that we have the adequate skills to be able to continue our high standard of training at Marcoola.

Further to above, training and assessing is a brilliant pathway in lifesaving if you wish to pursue it. I have been blessed with many opportunities that I usually wouldn't have had access to in another profession. These qualifications are also nationally recognised, which makes you very employable. A trainer needs many qualities to be successful, employers can instantly see that when they read your resume. I would ask you to highly consider following this pathway, the club will support you all the way.

For those that do not know, currently the Bronze Medallion is equivalent to a Certificate II in Public Safety (Aquatic Rescue) – PUA21012. A new training package was released on 16/07/2019, PUA20119. SLSA have been gearing up to release this new package to our members, this will include key changes to the Bronze Medallion training, as well as more content in the Skills Maintenance in the coming season. In anticipation for the new training package next season, myself and the TAF team will do everything we can to wrap our heads around it before we start training in September (hopefully). It is exciting to think that we will have some new knowledge to teach very soon.

With more time on my hands recently, I have been able to start implementing further improvements to the training calendar for next season. I look forward to these changes, especially around getting the best out of Skills Maintenance. I will also specifically target gaps in our patrol roster to make sure that we have plenty of qualified Life Savers on each patrol team. As with using any new resources there will be teething problems, but I am looking forward to training current skills and knowledge to current and future members.

Again, a big thankyou to my TAF team, I can't do it without you! Look forward to seeing you all next season, in whatever shape or form that may look like!

"To deliver a quality lifesaving program for all members with a focus on surf awareness, surf safety & improved surf skills with an emphasis on FUN."

I think it's safe to say we 'smashed it'. In penning this report, I do hope that I'm able to portray my sincere appreciation to all contributors & do justice to the enormous successes we have had experienced again this season. So here goes....

Our Seasons Highlights:

Supporters Club Presidents Report - Craig Hunter-Smith

The last twelve months of the commercial operations of the Marcoola Surf Club has seen an unprecedented number of changes, internally and externally. A new Club Manager, new Executive Chef, some new Committee members, all producing exciting changes to deliver a Club which the community could take a great deal of pride in. Then COVID-19. It has slowed us in the development of our product but this is only a short time delay and I am sure that we will be back on track very quickly.

It was very encouraging to see the staff responding to the needs of our community during COVID-19 with the delivery of food to those in need. A job well done to all. This shows the true community spirit which the Club is renowned for.

A sincere thanks also goes to the Government initiative of the Cashflow boost as well as JobKeeper, without which the Club would have lost significant reserves. To enable the majority of our staff to remain attached to the Club was instrumental in guaranteeing a recent successful re-opening.

The financial results were very encouraging pre-COVID-19. We achieved our budgeted rental commitment of \$150,000 as well as the cash donations of \$100,000. We were on target to provide an over-budget result, however, the forced closure of one and a half month's trading obviously impacted the final result. The surplus of \$306,136 reflects a great team effort.

Thanks must go to the Australia Day committee as the Marcoola Rocks function again proved to be a resounding success. The event is now firmly accepted as a major attraction and hopefully, with the support of our local community, we will continue to build on this success.

Gaming has seen a good increase in revenue and the Marcoola Club continues to be rated highly within our region. As is usual a gaming audit was performed by the State government with all items adhered to. Three new machines were purchased during the year and together with the upgrade of various games, the returns are proving to be the best performance we have received for the last six years. Bistro 103 is regarded as one of the best dining options in our extended community providing quality food at good prices. The quality and presentation of the food is outstanding, and congratulations must go to Adam and his team. The Bar continues to be the focal point of the Club and the staff are always excellent in their service delivery. Congratulations to the team for providing the family-friendly service Marcoola SLSC is renowned for. A special thank you to the Club Manager Jono McCosker for his dedication during a very difficult last few months. Jono's enthusiasm leads the team and reflects our customer relations. I'm looking forward to tackling future planning with Jono and the team.

I would like to thank the committee for the giving of their time over the past year. The committee comprises long-standing members Peter Hourn, Rob McGregor, Peter Ward, and Ian Hunter with the new boys being Drew Palmer and Corey Janssen. The meetings have always been congenial and progressive, and it is important that we continue to look over the horizon and continue to develop our Club to meet the community's needs.

I would also like to take this opportunity to thank the major sponsors of the Supporters Club who with their generosity make donations for the benefit of our Surf Club and support and sponsor our Club and all events. We truly appreciate your financial support and without your dedication and support, our Club could not be where it is today. Thanks to all our business partners and sponsors.

Finally thanks to all the patrons who have supported the club over the past year. We hope that you continue to support the Marcoola Surf Club as we intend to continue to provide the same efficient and friendly service with our current facilities for many years to come. From the committee, management and staff we look forward to seeing you at the club during the upcoming year.

Supporters Club Treasurer - Rob McGregor

Wow, that year was a bit different. A change of manager and then a total shutdown, nearly 6 weeks before the end of our trading year. That meant our operating surplus was down by \$70k for the year. But still resulted in a surplus of \$306k. The supporters club made total payments (donations and rent) to the Marcoola Surf Club also of \$306k.

There are some people I would like to thank and also some financial highlights and observations to point out. Firstly, I would like to thank all our awesome frontline team in the bar and bistro. My personal opinion and a view shared by our patrons, I believe, is that they are as good as any team we have had. Well done to Jono and Leigh for leading the team through an "interesting" year.

Bistro food standards have been consistently high, and our super friendly bar team make members and guests feel very welcome and always go about their work with a smile and a personal touch. Well done Team. It was gratifying that we were able to keep fourteen team members on JobKeeper during the lockdown and at the time of writing we are reopening with the same loyal and dedicated crew.

I would like to thank the rest of the committee for their continued top efforts this year and many years in the past. We are very ably led by President Craig Hunter Smith whose vast experience was invaluable during this crazy year. Thanks, Craig for guiding the club so wisely through a tumultuous year.

For what it's worth (given we missed 6 weeks of trade – including Easter), some financial highlights below:

Our income in all three key areas of the Supporters Club was solid:

- Bar Sales down only 0.5 %
- Bistro Sales down only 0.6 %
- Gaming Income actually up 6%

Gross Profit was down 0.9% on Bar Trade, up 8.2% for the Bistro and up 6.2% for gaming. Total operating expenditure was up 10.3% which left our total Operating Surplus down 18.7% - a reasonable result considering it was cut short nearly 6 weeks.

From the Supporters Club Operations Manager - Jonathan McCoster

With a background in frontline Hospitality Management and having already been a part of the team here since 2016, I took on the Club Managers role in July 2019. Since my appointment, we have been able to build on the Clubs foundations: with a change in attitude and culture amongst the employees, innovation, changes to our Management structure, and many upgrades to the Clubs facilities. We achieved our main objective: to increase the everyday cashflow of the Club and meeting its primary function of financially supporting and sustaining the Surf Club's lifesaving activities.

We upgraded our Gaming Room to the industry standard card-based gaming system, providing a more private and seamless gaming experience for our patrons and taking the weight off the staff, who are now able to focus further on customer service throughout the club. We also purchased two new machines and turned over another six machines to the latest gaming software, which has kept us up to date with the current offerings from our competitors.

At the bar, we reviewed the current contracts with our main suppliers and renegotiated expired agreements securing the best possible pricing and support. This has enabled us to increase our draught beer range with the addition of four new beer taps, increasing options for our packaged beverages range, and most importantly kept our pricing competitive.

In entertainment, we've built a great relationship with local professional musician Carl Lynch, who not only regularly plays at the Club but also sources and handles most of the upcoming artist bookings and assists with larger entertainment events, such as the successful Marcoola Rocks Australia day event. This has proven to be a great partnership as we have managed to foster a reputation for having great regular entertainment in the live music scene.

In our restaurant, we welcomed a new Head Chef Adam Watkins who with his team of Chefs launched 'Bistro 103' with a competitive diverse menu which improved the Clubs dining experience and was reflected favourably in reviews and feedback.

The air-conditioning system was given a much-needed upgrade upstairs as well as a new CCTV system, which has given us the ability to assist management in dealing with incidents and provide footage to improve the smooth functioning necessary for a club of our size. A new audio/visual system has enhanced the Clubs atmosphere and provided our members and visitors with vital in-house communication of events, deals, functions and regular events.

The Governments JobKeeper program allowed us to retain our employees while we coordinated the reopening of the Club, and to progress unheeded to foster a safe and friendly space. Our staff were encouraged to take on transitional tasks in maintenance, procedures and marketing to get the Club prepared to reopen. COVID-19 was a curveball that we managed to dodge with the help of Clubs Queensland's policies and procedures. We were lucky to have a dedicated team who worked well together, in coordination with the procedures and maintained a stress-free environment, amid the uncertainty.



I would personally like acknowledge our Committee for their unwavering support and for the opportunity to take the Club to the next level and particularly to Craig Hunter-Smith for your leadership, advice and mentoring, Amanda Janssen for your enthusiasm, commitment and advice as well as Lyn Mathison for your candour and coming out of retirement.

Special thanks go to Leigh Briggs in her 2IC role for her support, encouragement and drive, as well as her focus on our Gaming's capabilities, which provides the Clubs financial backbone. Thanks to Charlie who stepped up this year to take on a vital Duty Managers role. Thanks to Tahnee for your passion, energy and

hard work. Last but certainly not least our casual kitchen, floor and bar staff who bring vital flexibility and friendliness to their roles. We are lucky to have a reliable, hardworking and dedicated team!

We are a community-based organisation with seasonal opportunities. The Club will benefit from bridging-the-gap between 'upstairs' and 'downstairs' by maintaining alignment of each other's functions and mutual ambitions. This is a novel time; we have proved that when a community is faced with a challenge it can show solidarity by coming together and paying it forward.

Note 1 Summary of Significant Accounting Policies

Financial Reporting Framework

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 1981 (Queensland). The committee has determined that the association is not a reporting entity.

Statement of Compliance

The financial report has been prepared in accordance with the Associations Incorporation Act 1981 (Queenstand), the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054: Australian Additional Disclosures.

Basis of Preparation

The financial statements have been prepared on an accrual basis and are based on historical costs. They do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

(a) Income Tax

The income tax expense (income) for the year comprises current income tax expense (income). The Association does not apply deferred income tax expense (income).

(b) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful fives of the improvements.

The depreciation rates used for each class of depreciable assets are:

(c) Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible assets to determine whether there is any indication that those essets have been impaired. If such an incidention exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value fees costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

(d) Employee Provisions

Provision is made for the association's flability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

(e) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow cent be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

ifi Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(g) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(h) Leases

The Association as lessee

The Association has a short term lease in place for the lease of premises from Marcoola Surf Life Saving Club. As it is a short term lease, the lease has been expensed as it is due and AASB16: Leases does not apply.

(ii) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and flabilities statement.

(i) Revenu

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume relates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Revenue recognition

The Association has applied AASB 15: Revenue from Contracts with Customers (AASB 15) and AASB 1058: Income of Not-for-Profit Entities (AASB 1058) using the cumulative effective method of initially applying AASB 15 and AASB 1058 as an adjustment to the opening behavior of quility at 1 January 2019. Therefore, the compressive information has not been restated and continues to be presented under AASB 118: Revenue and AASB 1004; Contributions. The details of accounting policies under AASB 118 and AASB 1004 are disclosed separately since they are different from those under AASB 15 and AASB 1058, and the impost of changes is disclosed in Note 1.

In the current year

Interest income is recognised using the effective interest method.

income from sale of good

Revenue is recognised when control of the products has transferred to the customer. For such transactions, this is when the products are delivered to the customers. Revenue from these sales is based on the price stipulated in the contract. Revenue is then only recognised to the extent that there is a hind probability that a stantificant reversal of revenue will not occur.

A receivable will be recognised when the goods are delivered. The Association's right to consideration is deemed unconditional at this firms as only the passage of time is required before payment of that consideration is due.

All revenue is stated net of the amount of goods and services tax.
